### **Commissioner's Discussion**

Jeryl Olson gave a report of the October Advisory Committee:

- The committee noted the change of plans to go out to public bid on the practice arena instead of the front west elevation. The AC also requested the Board go out to public bid on the arena expansion on the west elevation.
- Recommended a canvas or aluminum roof overhang be built over the kennel's concrete pad on the north elevation. The AC received a quote for \$2,000.00 In addition to the roof overhang, the AC would like three horse stalls added to the kennel and it was reported that the stall doors are already in the kennel .
- Recommended purchasing an additional round pen, with or without footing, placed between the kennel and garage area
- Interior work for the Kennel would include taking out the concrete dog beds and a garage door added to one side.
- A request to raise the tree canopy and deadwood cut from the trees near the Hunt House and garage.
- A request to give all AC members a BHPD email address for Park District communications.
- A new At-Large member for the Advisory Committee is needed and Jeryl requested the Board help find a candidate.
