Commissioner's Discussion

The Advisory Committee report for July included the following:

- The Advisory Committee recommends Ashlee Lazic be appointed as an At-Large Member
- The Board was asked to consider building a screened-in front porch along the south-facing side of the Hunt House.

A facility rental request for a dressage clinic on August 20th was reviewed, however, because the rental was from an individual and not one of the cooperative organizations or a non-profit organization, the application was denied.

The Board reviewed Meredith Halas's trainer registration but will only authorize her registration if she agrees to not drive a motorized vehicle into the Forest Preserve to teach lessons.

The Board reviewed but did not authorize the trainer registration from Emma Kane for the following reasons: Her certificate of insurance requirements were not met, as the Park District was not listed as an additional insured; proof of medical malpractice insurance will be required because of the patient/client nature of her training; concerns about the safety of having her patients, who may be non-equestrians, in close proximity to a horse that is loose in a tight, confined space.

Horizon Farms Update: Kevin Ward will mow the outside of the race track and will seek the Forest Preserve's approval to herbicide and regrade the track area. The Park District will contact Steve Gregory to get a cost estimate to clear fallen trees blocking access to the McGinley trail.

The Park District's preparations for the Village's Fall Festival event include sponsoring Pony Rides and handing out small give-away items for the children. Erin Torres will tend the Park District's table at the event.
