Drew McMahon will provide a list of equipment to purchase so an internet connection will be available at the Hunt House and video cameras can be installed at the Tractor Shed and the Indoor Arena.

There was discussion on the new plexiglass windows installed in the Indoor Arena. Positive comments included added light during the daytime hours and the ability to see out for security reasons, but there were some concerns over reflections at night that may affect horses or riders. It was also noted that a light should be installed outside the plexiglass windows in order for riders to see outside at night. The Board adjourned to inspect the plexiglass windows in the indoor arena.
